



Travis Johnson is an Outstanding County Attorney. I am casting my vote for Travis Johnson, and Clay County would be better off if you did, too.




Chuck Illig – Retired DHS Social Worker


Travis did not take the easy way out. He fought and made sure Clay County was protected. I am a registered Republican and I will be voting for Travis Johnson.

This isn't about Blue/Red. It's about every citizen being able to know they live in a community where they are safe.




Chris Anderson – Local Law Enforcement


Jessica Amendt – Program Director at Discovery House
